

#### **Managing HSE&Q**

Transoceanic Projects & Development (TPD) aims at delivering the best practice to the customer, every time. We do this by formalizing Business Processes; integrating Health, Environment and Quality in how we work.

At TPD we are working on integrating the HSE&Q Management System into one system.

#### **HSE&Q Commitment**

At TPD we are committed to protecting the health and safety of persons involved in, contributing to or affected by our work activities.

Management commitment is essential to achieving HSE&Q excellence, practicing a systematic approach in all our business practices and operations.

TPD ensures that Subcontractors are familiar with our minimum requirements. Everyone who works for or on behalf of TPD is responsible for their safety and the safety of those around them. TPD stresses the importance and expect subcontractors to demonstrate commitment to HSEQ throughout their organization; carrying out their work in a safe and sound manner.

#### Proactive approach to HSE&Q

TPD demonstrates commitment to HSE&Q by enhancing a proactive and positive HSE&Q oriented culture ensuring our subcontractors are equally committed to HSE&Q. Our HSE&Q Culture is based on bringing no harm to people or property, to act responsibly with respect to our environmental impact and to be the best in what we do, offering excellent quality, governed by formalized processes.

We can always take the time to work safely. Together with our subcontractors we identify impacts and risks arising from our activities enabling us to address, evaluate and act towards reducing and mitigating these risks to a tolerable and acceptable level. Together with our subcontractors we integrate HSE&Q in how we operate.

#### **Inspection & Audits**

HSE&Q Performance and systems implemented are monitored, measured and reviewed to ensure continuing suitability, maintenance, effectiveness and continual improvement. This includes the performance of our subcontractors.

#### **Safety Rules**

Everyone who works for or on behalf of TPD is responsible for their safety and the safety of those around them. Safety rules are TPD's minimum requirements in respect to personal safety and are key controls which workforce must comply with operationally.

## TPD's Foreign Corrupt Practices Act Policy



#### I. Purpose

The purpose of this Policy is to ensure compliance by Transoceanic Projects & Development and its directors, officers, employees, agents, consultants and representatives with the US Foreign Corrupt Practices Act ("FCPA") and related laws of other countries in which TPD does business.

#### II. FCPA

#### 1. Anti-Bribery

The FCPA is a US Federal Statute prohibiting US companies and their officers, directors, employees and agents from: giving, promising or offering anything of value, whether directly or indirectly, to any foreign official with the intention of obtaining or retaining business or obtaining an improper business advantage.

#### 2. Record-Keeping

The FCPA also requires US companies to keep books and records that accurately reflect transactions and dispositions of assets and to maintain a system of internal accounting controls.

All Transactions involving TPD funds or assets should be recorded accurately and in reasonable detail.

#### 3. Penalties for Breach

Where the anti-bribery provisions of the FCPA are breached, the following penalties may be imposed: Fines of up to US\$2 million against the company; Prison terms of up to five years and fines of up to US\$100,000 per violation for individuals involved; Willful violations of the record-keeping provisions may result in up to 20 years imprisonment and US\$5 million fines for individuals and up to US\$25 million for companies.

#### **III. Policy**

## 1. Prohibition of Bribery of Foreign Official

Under no circumstance shall any director, officer, employee, agent, consultant or representative give, pay, offer, promise to pay, or authorize the giving or payment of money or other things of value to any foreign official or to any person while knowing or being aware of a probability that the payment or promise to pay is being made to or will be passed on to a foreign official.

## 2. Prohibition of Payment or Gift in Violation of Law

Under no circumstance shall any TPD person make, offer, promise, or authorize any payment or gift in violation of local law in any country.

#### 3. Prohibition of Circumvention of Law

Under no circumstance shall any TPD person enter into any transaction that is intended or designed to circumvent the laws of any country. Any transaction that has the appearance of circumventing the laws of any country must be avoided.

## 4. Prohibition of Lawful Payment without Prior Approval

Under no circumstance shall any TPD person offer, pay, promise or give any money or other thing of value to any foreign official without the prior written approval of the **President and owner** 

#### 5. Clarification of Uncertainty

Without prejudice to the foregoing requirement for written approval a TPD person must promptly contact the **President** when questions arise concerning the FCPA's anti-bribery provisions including whether: a particular individual or entity must be treated as a "foreign official" whether something qualifies as anything of value whether a proposed payment would be made or seen to be made to obtain, retain or direct business dishonestly.

## 6. Due Diligence and Third-party Certification

All persons must ensure that business relationships are formed only with reputable and qualified partners, agent and representatives. In negotiating any business relationship.

#### 7. Prohibition of Improper Accounting

Any "improper transaction" or deviation from established accounting practices, including omitted or falsified expense reports, strictly prohibited.

#### 8. Compulsory Compliance

Every person with TPD will comply with all rules and regulations in accordance with the FCPA Policy.

#### 9. Chief Compliance Officer

The **President /Owner** is the Chief Compliance Officer for all FCPA matters. Any question regarding activities under consideration with regard to the FCPA or this Policy should be promptly directed to the President.

#### 10. Zero Tolerance

TPD will not tolerate any person that achieves or purports to achieve results by violation of law or by acting against and contrary to FCPA Policy.
